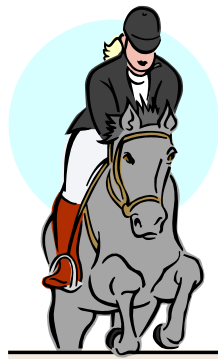
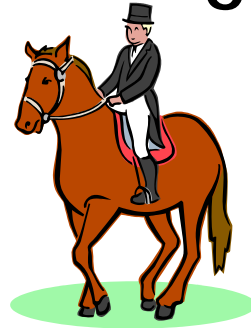

Directions to MiraBella

From East: NYS Thruway to Exit 16 (Harriman). Immediately after toll booth, follow signs for Route 17W. Continue on Route 17W to Exit 126. At end of exit ramp, turn left onto Rte. 94S. Go approximately 5 miles to traffic light & turn left onto Rte. 94S/Rte.17A. At the first light, turn right onto Bridge St. *****Go 3/10 mile, bear left onto Highland Ave. Continue 1 mile on Highland Ave. (It becomes Jessup Rd) and turn right into MiraBella's driveway.

From West: Take Rte. 17E to Exit 124. At end of exit ramp turn left onto Route 17A. Go approximately 4 8/10 miles into Village of Florida. At light turn right onto Bridge St. *****follow directions from above.

Dressage: All dressage classes will be held in a 20 x 60 meter indoor arena.

Jumping: Will be a combination of **Cross Country and Stadium.**

Stadium class will be held outdoors in a sand/rubber arena immediately following the Dressage test.

Cross Country is field terrain.

Entry fee: \$50 for mini event division.

Prize and 6 ribbons per division will be awarded .

Clear Round Jumping Only: You may enter any level and jump either the stadium and/or the cross country course separately (not counted in the division) -- \$25 per round

Closing Date: August 18, 2010

- **All entries must be received by the above date.**
- **Negative coggins within 12 months must be included.**
- **No refunds after closing date.**

Additional Eventing Information

1. Dressage Test score, combined with faults from stadium jumping and cross country is used to determine winner.
2. Rail knocked down - 4 faults
3. Refusal at jump - 10 faults 1st - 20 faults 2nd
Eliminated after 3rd refusal.
4. Time Faults Penalty -Every second over time: 1 fault
5. Informal but neat attire is to be worn.
6. Proper ASTM approved headgear **MUST** be worn when mounted.
7. No Dogs or unentered horses allowed on grounds.
8. No smoking permitted.
9. **NO** food will be available.
